LIVING ASSISTANCE: IN 2023 THE AGENCY CONTINUED GROWING BY INCREASING SERVICES FOR VETERANS AND RECENTLY ARRIVED MIGRANTS: UNITED WAY OF BROWARD AWARDED \$750,000 TO COVER SALARIES AND EXPENSES TO SERVE VETERANS EXPERIENCING HOMELESSNESS IN MIAMI DADE COUNTY. THE AGENCY INCORPORATED AT LEAST 5 NEW EMPLOYEES TO SERVE THIS POPULATION.
